post-conviction relief pursuant to Florida Rule of Criminal Procedure 3.850. We have jurisdiction. Art. V, § 3(b)(1), Fla. Const. Brown entered no contest pleas to charges of second-degree murder and armed robbery and was sentenced as an habitual offender to life imprisonment for the murder and to twenty years in prison for the armed robbery. He raises two claims in his motion for post-conviction relief.

The trial court summarily denied his claims and Brown appealed. The First District Court of Appeal affirmed, and Brown subsequently filed this motion for post-conviction relief. The trial court summarily denied the claims presented in Brown's motion. Brown raises two issues for our review, which we rephrase as claims of ineffective assistance of appellate counsel. The two allegations which Brown challenges in his post-conviction motion and which were briefed and argued before the First District are (1) the trial court erred when it failed to rule on Brown's motion to withdraw his pleas; and (2) appellate counsel was ineffective for failing to raise this issue on direct appeal.

Regarding the trial court's order denying the motion to withdraw his pleas, Brown's allegations of ineffective assistance are procedurally barred. This Court has long held that "a trial court's denial of a motion to withdraw a plea is not reviewable on appeal unless that motion is based on an attack, on constitutional grounds, on the judgment and sentence."
